However, a few more suggestions for modification have been received from partnering departments for improving the formats prescribed. To that extend the Forms A, B, and D need be improved up on as indicated below.

1. FORM - A: the Serial No. of the Household given as item No.9 in the Identification Particulars may be removed as the same is once again called for in the subsequent section.
2. FORM- B: the Sl. No. of Household given as item No.9 in the Identification Particulars may be removed as the same is once again called for in the subsequent section in the same format.
3. FORM-B: the portion, "I request that the following correction(s)/ modification(s) concerning myself and other member(s) of my family appearing **at serial number(s)**.....in the Draft Publication of Information ...."

The above sentence may be corrected and read as follows:-  
" I request that the following correction(s)/ modification(s) concerning myself and other member(s) of my family appearing **as serial number of the household**.....in the Draft Publication of Information ....".

4. FORM -B the Col. No 2 - "Serial Number of the HH in the draft **BPL** Publication" may be corrected as , "Serial Number of the HH in the Draft **SECC** Publication".
5. FORM -D. the sentence is started as, "Take notice that objection to the inclusion of your name at Serial No..... of the draft publication of information for SECC 2011 ....".

The above only refers to inclusion of name but the objection may be pertaining to other items also (like, owning an asset etc.). In such a situation to take care of the same, the above sentence need be modified and read as follows.

Take notice that objection to (a) the inclusion of your name at Serial No..... and (b) other specific objections..... of the draft publication of information for SECC 2011 in the Ward/Town/Village/EB/Sub Block".

Let me request you to take note of these suggested changes and make necessary modifications in the formats of the SECC 2011 Claims and Objections procedures at the earliest.
