DEPARTMENT OF RURAL DEVELOPMENT, GOVERNMENT OF UTTAR PRADESH INVITES EXPRESSION OF INTEREST (EoI) FROM WELL REPUTED FIRMS IN THE FIELD OF INFORMATION TECHNOLOGY (IT)/ INFORMATION TECHNOLOGY ENABLED SERVICES (ITES) FOR CONVERSION OF BPL DATA IN RASHTRIYA SWASTHYA BIMA YOJNA (RSBY) FORMAT, MATCHING THE BPL RURAL DEVELOPMENT DEPARTMENT AND STATE FOOD AND CIVIL SUPPLIES DEPARTMENT, DATA DIGITIZATION AND OTHER RELATED ACTIVITIES

The Rashtriya Swasthya Bima Yojna (RSBY) has been launched to provide health insurance coverage for Below Poverty Line (BPL) families. The objective of RSBY is to provide protection to BPL households from financial liabilities arising out of health shocks that involve hospitalization. The details about RSBY scheme could be accessed from the website http://www.rsby.in. In the state of Uttar Pradesh, RSBY has been now extended in all the 71 districts. To take the scheme further, it is required to convert BPL data in the prescribed RSBY format. There are approximately 1.08 Crore BPL families in both Urban and Rural Uttar Pradesh and out of which about 99,56 Lakhs are Rural BPL. The BPL list of rural area is available in digital form and is also on the site of each district, but there is no such list in urban area. This list in urban area in digital form in required format is to be prepared from the hard copy to be made available by the Food and Civil Supplies department. There may be cases in rural areas where every Antodaya and BPL card holder do not figure in BPL list of rural development, and vice-versa, every family with hame in BPL list may not be in possession of AAY/ BPL card. This calls for digitization of the details of card holders in rural areas to enable matching and subsequent reconciliation. In the reference above, Department of Rural Development, Govt. of U.P. is inviting E.o.I. from competent firms for conversion of BPL data in RSBY format, data digitations and other related activities as mentioned below –

Broad Scope of Work

- a. Conversion of BPL data in RSBY format for Rural Uttar Pradesh. The RSBY format may require data in various heads like details of all the family members including name, father or husband's name for the head of household, age, gender and relationship with the head of household etc. Soft copy of the same data shall be made available for conversion.
- BPL Data including Antidaya card holders digitization in RSBY format for urban areas of Uttar
- RSBY data validation as per RSBY Software.
- Uploading of RSBY data in central RSBY database / RSBY website after the validation and clearance from Ministry of Labour, Government of India.
- e. Data digitization of the families/ individuals having Antodaya Cards and BPL Cards in Rural areas. This data digitization needs to be done from the records available with the Department of Rural Development and Food and Civil Supplies, Govt of Uttar Pradesh.
- To develop a software program for matching between BPL / Antyodya Cards holders and BPL list. The process also involves 5% ground truth verification.
- Places where soft copy data is not available, the BPL data feeding in RSBY format shall be required to be done.

Eligibility Criteria

- a. The firm should be registered in India and should be in IT business from last 5 years.
- b. The firm should have past experience of working in data digitization/ computerization, handling large databases in Government departments.
- The firm should not be black listed from any government department or any state. d. The annual turneyer of company should not be less than Rs.10 Crores / Year from last three years and IT/ICT based business turnover should not be less than Rs.5 Grores / Year-from last

three years.

Response and Submission of E.o.l

Firms qualifying above criteria and having suitable & sufficient manpower are encouraged to apply with details and proof. Eol from the participants should be submitted in sealed envelope and marked as E.O.I. for CONVERSION OF BPL DATA IN RASHTRIYA SWASTHYA BIMA YOJNA (RSBY) FORMAT, DATA DIGITIZATION AND OTHER RELATED ACTIVITIES.
